OFFICIAL CONTEST RULES

1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.
2. Eligibility. The Fertility Center Contest is open to all residents residing in the United States. To enter the Contest, you must be 18 years or older at the time of entry. Employees of The Fertility Center and each of their respective affiliated companies, subsidiaries, advertising or promotional agencies, and other agents, and the immediate family members of, and any persons domiciled with such employees, are not eligible.
3. Entry. The Fertility Diaries Contest begins on Monday, April 1, 2019, and all entries must be received by midnight on Sunday, April 14, 2019, (the "Contest Period").

Internet Entry: Enter by visiting The Fertility Center's official contest section on The Fertility Center's website, www.fertilitycentermi.com/contest, and completing all of the required information and following all instructions. Submit your entry by clicking on the "SUBMIT" button. Your computer must accept cookies, or any successor or similar technology, which may be used for the purpose of entry tracking. By entering, you agree to the terms of these official rules and to receive emails from Sponsor or those directed by Sponsor. You can opt-out of the receipt of any email received from Sponsor.

One entry per individual.

The Fertility Center (referred to as 'Sponsor') will not be responsible for incomplete, lost, late, misdirected or illegible entries, or for failure to receive entries due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any telephone connection, network, hardware or software, whether originating with sender or Sponsor. In the event of a dispute, all online entries will be deemed to have been submitted by the owner of the email account from which they were sent. For these purposes, an email account holder shall mean the natural person assigned to such email account by the internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with such email account. All entries become the property of Sponsor and none will be returned. Any questions regarding the number of entries submitted or the owner of an email account shall be determined by Sponsor in its sole discretion, and Sponsor reserves the right to disqualify any entries by persons determined to be tampering with or abusing any aspect of the Contest.

The Second Prize winner will receive \$2,500.00 towards future office services at The Fertility Center. The Third Prize winner will receive \$1,000.00 towards future office services at The Fertility Center. All confirmed entrants will receive a \$50.00 credit towards future office services at The Fertility Center. If entrant chooses not to continue with any future services, all remaining prize money and/or the \$50.00 credit will be forfeited. There will be no cash compensation offered in the event that the credit is not used. The first date that the credit may be used is Monday, May 5, 2019. It will not be applied to any balance accumulated prior to this date.

Odds of winning depend on the number of eligible entries received. Contest may be presented in multiple presentations and in other media, and the odds of winning may depend on the number of eligible participants who enter the Contest through such multiple presentations.

5. Winner Notification and Acceptance. Winner will be notified by telephone or email at the telephone number or email address provided on winner's entry form. Failure to reach winner may result in disqualification of the winner, forfeiture of his/her interests in all prizes, and selection of a substitute winner from among all remaining eligible entries. In the event the Contest is compromised by a virus, non-authorized human intervention, tampering or other causes beyond the reasonable control of Sponsor which corrupts or impairs the administration, security, fairness or proper operation of the Contest, Sponsor reserves the right in its sole discretion to suspend, modify or terminate the Contest. Should the Contest be terminated prior to the stated expiration date, Sponsor reserves the right to award prizes.
7. Limitations of Liability. By entering the Contest, entrant agrees that (1) any and all disputes, claims, and causes of action arising out of or in connection with the Contest, or any prizes awarded, shall be resolved individually without resort to any form of class action, and entrant waives his or her right to a jury trial for such disputes, claims, and causes of action; (2) any claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Contest, but in no event attorneys' fees; and (3) under no circumstances will any entrant be permitted to obtain any award for, and entrant hereby waives all rights to claim punitive, incidental or consequential damages and any and all rights to have damages multiplied or otherwise increased and any other damages, other than damages for actual out-of-pocket expenses.

The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. If any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the valid or enforceable provision was not contained therein.
